**Re: Notice of Proposal Under Section 81 of the *Ontario Energy Board Act, 1998*
as submitted by Kruger Energy Inc. (the "Notice")
Board File Number EB-2007-0691**

We are counsel to Kruger Energy Inc. ("KEI") in the above-stated matter.

Pursuant to Procedural Order No. 5, issued June 11, 2008, the Ontario Energy Board (the "Board") has requested that KEI provide the Board and intervenors in the proceeding with alternative dates on which to hold a Technical Conference in the above-stated matter.

In its June 9, 2008 letter in which KEI requested an adjournment of the June 12, 2008 Technical Conference, KEI suggested that any Technical Conference should take place after the release of the revised RESOP rules and new contract which was targeted for the week of August 25, 2008. KEI notes that to date the revised RESOP rules and new contract have not yet been issued.

KEI however takes notice of the Board's direction in Procedural Order No. 5 stating that the Board will not allow a further adjournment of the Technical Conference and that the Technical Conference must proceed before the end of September 2008. Therefore KEI proposes September 18 or September 19, 2008 as possible dates on which to hold the Technical Conference.

In accordance with the Procedural Order, KEI is copying the intervenors in order that they might make their availability to attend on either of those two dates known to the Board.
