EB-2007-0691 - KRUGER ENERGY INC. - PROPOSAL UNDER SECTION 81

Please excuse our late submission of this letter. The notice of application did not come to our attention as it was only published in local Chatham-Kent newspapers which escaped our notice.

We seek intervenor status regarding this matter. Invenergy Wind Canada ULC ("Invenergy") has direct interest in the Kruger plans for a transmission substation ("TS") in the Bloomfield area of Chatham-Kent. Invenergy has been frustrated in its attempts to obtain distribution-connected queue positions with Hydro-One in this area given the limited capacity of the Kent TS.

Invenergy has, to its knowledge, the largest position in wind energy projects in Chatham-Kent, with over 200 MW of possible transmission connected projects in the former township of Raleigh, Chatham-Kent (adjacent to Kruger's proposed Bloomfield TS), and three frustrated ("below the red line") and one active Hydro-One CIA applications for distribution connected project at Kent TS. In addition, Invenergy has 200 MW of possible transmission connected projects in the former township of Dover, Chatham-Kent, two frustrated ("below the red line") and two active Hydro-One CIA applications for distribution connected project at Wallaceburg TS.

Invenergy intends to actively participate in these proceedings if granted intervenor status, when necessary, and wishes to reserve the right to address any issues it deems relevant and material to its interests.

In addition, Invenergy has both experience and expertise to make submissions to assist the Board in its determination of the economic prudence and cost effectiveness of the Kruger proposal.

Invenergy would wish to ensure that it can obtain access to the proposed Kruger Bloomfield TS.
