**Re: West Perth Power Inc. – 2008 Incentive Regulation Mechanism Rate Application EB-2007-0871**

West Perth Power Inc. received the following interrogatories from Board staff and attached are the following responses.

1. A review of your current 2007 Board approved Tariff of Rates and Charges indicates that one of your rate classes is the General Service 50 to 4,999 kW, however, your 2008 model does not reflect this. You have selected General Service 50 to 499kW as a rate class, which is not a rate class in your 2007 Board approved Tariff of Rates and Charges.

Reference 2008 Model, Sheet 2 (Rate Classes)

2. A review of your current 2007 Board approved Tariff of Rates and Charges indicates that the Retail Transmission Rate – Line and Transformation Connection Service Rate for General Service 50 to 4,999 kW class is 2.997/kW, however, your 2008 model (where you have selected General Service 50 to 4999 kW as a rate class) does not reflect this.

Reference 2008 Model, Sheet 3 (2007 Tariff Sheet)

WPPI only has one rate class for General Service > 50 kW. The correct range should be up to 4,999 kW not the 499 kW indicated in the 2008 IRM.

3. **A review of your current 2007 Board approved Tariff of Rates and Charges indicates that the service charge for the Unmetered Scattered Load class is applied on a per connection basis, however, your 2008 model does not reflect this.**

**Reference 2008 Model, Sheet 3 (2007 Tariff Sheet)**

WPPI intends to charge the service charge for Unmetered Scattered Load customers on a per connection basis. This was an error in our originally filed model.

4. **A review of your current 2007 Board approved Tariff of Rates and Charges indicates that the Distribution Volumetric Rate, Regulatory Asset Recovery charge and Retail Transmission Rates (both Network Service Rate Line and Transformation Connection Service Rate) for the Unmetered Scattered Load class charges are applied on a \$/kW basis, however, your 2008 model does not reflect this.**

**Reference 2008 Model, Sheet 3 (2007 Tariff Sheet)**

This issue is again an error, as with the 2007 rate order the above noted rates should be charges on a per kW basis.

5. **A review of your current 2007 Board approved Tariff of Rates and Charges indicates that the service charge for the Sentinel Lighting class is applied on a per connection basis, however, your 2008 model does not reflect this.**

**Reference 2008 Model, Sheet 3 (2007 Tariff Sheet)**

WPPI intends to charge the service charge for Sentinel Lighting customers on a per connection basis. This was an error in our originally filed model.

6. **A review of your current 2007 Board approved Tariff of Rates and Charges indicates that the service charge for the Street Lighting class is applied on a per connection basis, however, your 2008 model does not reflect this.**

**Reference 2008 Model, Sheet 3 (2007 Tariff Sheet)**

WPPI intends to charge the service charge for Street Lighting customers on a per connection basis. This was an error in our originally filed model.

7. A review of you current 2007 Board approved Tariff of Rates and Charges indicates that the three Non-Payment of Account charges for Collection of account charge – no disconnection, Disconnect/Reconnect at meter – after regular hours, and Disconnect/Reconnect at meter – during regular hours are applied on a “\$” basis, however, your 2008 model does not reflect this.

**Reference 2008 Model, Sheet 3 (2007 Tariff Sheet)**

WPPI charges these rates on a \$ basis and not on a % basis. This was an omission from our original IRM filing.

8. A review of your current 2007 Board approved Tariff of Rates and Charges indicates that the Transformer Allowance for Ownership – per kW of billing demand/month is applied on a “\$/kW” basis, however your 2008 model does not reflect this.

**Reference 2008 Model, Sheet 3 (2007 Tariff Sheet)**

WPPI charges this rate on a \$/kW basis and not on a \$ basis. This was an omission from our original IRM filing.
