The Ontario Energy Board (OEB) has now re-issued its Notice of Hearing for Enbridge Gas's application for the **Bobcaygeon Community Expansion Project** (Notice). The Notice will be published by the OEB, in accordance with directions to the OEB's media agent which were copied to you. Please note that you must comply with the directions in paragraphs 1 through 3 below **prior to July 13, 2023**, which is the publication date of the newspaper in which the Notice will appear last. ## You are directed:

- 1. To conduct a search of title forthwith, sufficient to determine the current registered property owners and encumbrancers with lands or interest in the lands directly affected by the proposed pipelines and related facilities.
- 2. No later than the date the Notice is posted on Enbridge Gas's website in accordance with paragraph 3, to arrange for the service of the enclosed Notice, in the exact form accompanying this letter, the application and the evidence, directly on each of the following:
  - a. all property owners and encumbrancers with lands or interest in lands identified in the search of title referred to in paragraph 1 above

- 5. To provide a copy of the Notice, the application and the evidence, and any amendments thereto, to anyone requesting the material.

You are further directed not to include any documents or materials when serving the Notice other than documents or materials expressly required by this letter of direction to be served.
