Ontario Energy Board ("OEB") Hybrid Hearing Participation

We represent the Association of Power Producers of Ontario ("APPrO") in relation to the abovenoted Proceeding. On June 23, 2023, the OEB issued Procedural Order No. 6 convening a hybrid hearing from July 13, 2023 to August 3, 2023.
