Re: Enbridge Gas Inc. (Enbridge Gas, or the Company) EB-2022-0200 – 2024 Rebasing – Capital Update-related Exhibit Updates

Enbridge Gas filed its 2024 Rates Application and the majority of its supporting evidence on October 31, 2022 and the balance of its evidence on November 30, 2022. In this Application, Enbridge Gas requests approval of rates for the sale, distribution, transmission, and storage of gas commencing January 1, 2024. Enbridge Gas also applies for approval of an incentive rate-making mechanism (IRM) for the years from 2025 to 2028.

On June 16, 2023 Enbridge Gas filed a Capital Update in Exhibit 2, Tab 5, Schedule 4 reflecting Enbridge Gas's changes to its capital budget for 2023 and 2024. In correspondence dated June 22, 2023, Enbridge Gas stated it would identify the main evidence impacted by the Capital Update in Exhibits 1 (integration capital) and 2 (capital expenditures and rate base) as well as associated interrogatory and undertaking responses and share a list of Exhibits to be updated with intervenors. Enbridge Gas provided a preliminary list on June 23, 2023, and intervenors subsequently provided feedback on the items to be updated. In Procedural Order No. 6, the OEB directed that, among other things, Enbridge Gas file updates to the evidence related to the Capital Update by July 6, 2023.
