The Licensee is exempt from the requirements of section 2.5.3 of the Standard Supply Service Code with respect to the price for small volume/residential consumers, subject to the Licensee offering an equal billing plan as described in its application for exemption from Fixed Reference Price, and meeting all other undertakings and material representations contained in the contained in the application and the materials filed in connection with it. 2. The Licensee is exempt from section 3.2 of the Retail Settlement Code and section 2.2.2 of the Standard Supply Service Code with respect to the requirement of purchasing of power from an embedded retail generator within its service area to allow the continued purchase of energy from the Waltham Generating Station. This exemption expires on January 31, 2027. 3. The Licensee is exempt from the requirements of section 3.2 of the Retail Settlement Code in relation to payments for the supply of electricity from Brookfield Energy Marketing Inc. to the Licensee provided that the negotiated connection charge should not be greater than that paid by an embedded distributor in the IESO administered market such that the total annual benefit to the Licensee's customers is preserved
