Your application is currently incomplete and cannot be processed until the following has been filed:

- Section C12 –Information that indicates the applicant's financial state of affairs, i.e. the information provided should relate to the applicant, AtlaGas Energy Corporation Partnership, rather than the parent company, AltaGas Income Trust. If the applicant's financial statements are unavailable please provide one or more of the following additional items:
 - o a written guarantee from the parent company; or
 - a letter of reference from the applicant's bank.
- 2. Please resubmit Section D14 of the application form with **complete** information for all key individuals:
 - o for Brian Wood provide birth date and residential address;
 - o for Steve Yallouz provide residential address;
 - o provide information for key individual, Mike Kilby.

With reference to information about Key Individuals in Section D14 of the application form, please provide copies of two pieces of identification, one of which must include a photo. The information is necessary for the Board to conduct a police record check with the Ontario Provincial Police on the key individuals reported in Section D of the application.

3. With respect to Section A6 – Type of Licence, question a) the applicant responded that it does not intend to retail electricity to small-volume consumers in Ontario. However, in Section D10 of the application form – Intended Markets, the applicant responded to question a) that it expects to serve small-volume residential and general service customers. Please provide clarification.

The Board will resume processing your application once the above information has been filed. If the above information is not filed within 30 days of the date of this letter, the Board may close the file for this application.

Upon receipt of the required information the Board will issue an acknowledgement letter indicating the expected date on which a decision and/or order may be rendered.
