## Mandate and Objectives:

OGVG works to promote and connect its growers with government agencies, consumers, retailers and foodservice operators across North America through various government lobbying events, research, marketing initiatives, trade shows and community activities. As a whole, OGVG strives to support the Ontario greenhouse vegetable sector and its growers, however possible, to ensure success for today, sustainability for tomorrow, and fresh, nutritious, quality produce for all.

## Membership of the Intervenor and Constituency

### Represented:

The Ontario greenhouse vegetable sector is a major contributor to the Ontario economy, generating over \$820 million in farm gate receipts and accounting for approximately 10,000 jobs annually. OGVG, as an organization, represents approximately 200 greenhouse pepper, tomato, and cucumber growers in the province. Given the nature of greenhouse production systems, OGVG members are heavily reliant on energy, particularly natural gas. Over one third of greenhouse production costs are energy-related and as such rate increases and pricing adjustments serve to threaten the global competitiveness of the sector.

The Ontario greenhouse sector is growing. In fact, in evidence filed by Union Gas in its 2013 rate case, the greenhouse sector was shown to be the fastest growing sector of Union's business markets exhibiting a doubling of volume between the 2007 Board- approved and the 2013 Forecast volumes. In its recent application to increase the capacity on its Panhandle System EGI notes the continued growth of greenhouse related load on its system, with EGI forecasting that by the winter of 2030/31 40% of the total firm demand in the Panhandle System Market will be from greenhouses (EB-2022-0200, Exhibit I.APPrO.6). OGVG members' natural gas consumption is important to Enbridge Gas Inc. ("EGI") and greenhouse production in general is important to the Ontario economy.

## **Programs or Activities Carried Out by the Intervenor:**

The Ontario Greenhouse Vegetable Growers (OGVG) is regulated under the Farm Products Marketing Act (FPMA). Under Regulation 417 of this Act, OGVG is responsible for licensing all growers, packers and marketers of Ontario greenhouse tomatoes, cucumbers, and peppers. In addition to licensing, OGVG performs a spectrum of services for its members; areas of focus include research, food safety, energy, environment, market performance and marketing.

### **Issues:**

As (primarily) large gas users making up approximately 10-15% of EGI's contract rate customers, OGVG's members are directly interested in all aspects of the application insofar as they will be asked to pay rates that flow from the OEB's decision in this proceeding. OGVG's members have a substantial and direct interest in the proper administration and calculation of amounts in EGI's deferral and variance accounts, as well as the proper accounting of EGI's earnings sharing calculation.

### **Policy Interests:**

OGVG represents a specific group of identified ratepayers.

### **Hearings:**

No submissions.

### **Evidence:**

OGVG does not intend to file evidence in this proceeding.

### **Coordination with Other Intervenor:**

OGVG has an ongoing relationship with the intervenors that usually intervene in OEB

proceedings with respect to EGI's rates, and coordinates with them as necessary and possible. In this instance, where the focus of the proceeding is relatively narrow (confined to D/V account dispositions and ESM calculations) OGVG expects it will be able to avoid any significant duplication through its relationship with the other parties.

## **Cost Awards:**

As a not-for-profit organization, OGVG does not have other funding sources to ensure experienced representation to participate in and assist the Board with these regulatory proceedings. Therefore, OGVG would respectfully request a determination of eligibility for cost award in this consultation. OGVG retains professionals who have experience representing intervenor interests and, OGVG respectfully submits, have assisted the Board in previous proceedings in an efficient and responsible manner.
