We are submitting this letter on behalf of Union Energy Limited Partnership ("Union Energy LP") in response to the Notice of Application (the "Notice") by Enbridge Gas Distribution Inc. ("EGD") for rates for 2008.

1. Union Energy LP applies for intervenor status in these proceedings.
2. Union Energy LP's primary business is the rental and service of a portfolio of more than a million residential rental water-heaters, mainly in Ontario. In addition to Union Energy LP's rental water-heater business, it offers a number of products and services, most of which are complimentary to the rental water-heater business, including the rental, sale, servicing, installation of residential and some commercial HVAC equipment as well as a security monitoring business. Union Energy LP also finances the sale and installation of residential HVAC equipment through independent third party dealers. Union Energy LP's revenues are approximately \$320 million per year.
3. Union Energy LP intends to consider and address all matters pertaining to EGD's "Open Bill" proposal and EnergyLink.
4. Union Energy LP prefers an oral hearing on the grounds that an oral hearing is the most cost-effective manner for considering the issues that EGD's Application raises.
