APPLICATION TO THE ONTARIO ENERGY BOARD BY YOUR ELECTRICITY DISTRIBUTOR EB-2008-0149

Dear customer:

Your electricity distributor, Oshawa PUC Networks Inc. filed an application with the Ontario Energy Board requesting a continuation of the way in which your electricity is currently supplied. You are not required to take any action in response to this letter but you may wish to let the Ontario Energy Board know of any concerns you may have about the application.

As you know, you are currently a customer of Oshawa PUC Networks Inc. and are billed for electricity by Oshawa PUC Networks Inc. at its approved rates. However, you may not know that your electricity is supplied by Hydro One Networks Inc. You are within Oshawa PUC Networks Inc.'s service area but are actually served electricity by Hydro One Networks Inc. This arrangement is known as a long term load transfer.

The Ontario Energy Board requires electricity distributors to eliminate long term load transfer arrangements before January 31, 2009. However, Oshawa PUC Networks Inc. has applied to the Board for an order allowing it to continue its long term load transfer arrangement with Hydro One Networks Inc. for certain customers beyond January 31, 2009 to allow Oshawa PUC Networks Inc. to make necessary arrangements to supply those customers directly.

In your case, Oshawa PUC Networks Inc. intends to supply you directly by Date. Oshawa PUC Networks Inc would continue to serve your electricity needs, at the rates that are approved for Oshawa PUC Networks Inc, as is the case at present.
