LETTER OF DIRECTION

Dear Mr. MacDonald:

**Re: Hydro One Networks Inc.
Leave to Construct Application
Woodstock Area Transmission Reinforcement Project
Board File No. EB-2007-0027**

The Board has now issued its Notice of Application with respect to the above matter.

You are directed:

1. To immediately conduct a search of title forthwith, sufficient to identify the current registered property owners, those who hold encumbrances on the lands and those with any interest in the lands directly affected by this project;
2. To immediately serve a copy of the Notice of Application along with the location map and a copy of the Application, either personally, by courier, or by registered mail on:
 - a. All directly affected landowners, and to the extent that the project involves new, expanded or modified easements, on all encumbrancers identified by the search of title referred to in Paragraph 1;
 - b. Each electricity distributor within whose service area the proposed new or reinforced transmission facilities are or will be located;
 - c. All generators connected directly to the transmission line under consideration for reinforcement;

- d. All transmission customers of Hydro One Networks Inc. connected directly to the transmission line under consideration for reinforcement;
 - e. All owners and operators of rail lines, telecommunications (e.g., telephone) or other utilities along or crossing the routes proposed for the project;
 - f. The Clerks of all Municipalities that would be affected by the project;
 - g. The following federal government ministries and agencies:
 - i. Canadian Environmental Assessment Agency;
 - ii. Fisheries and Oceans Canada;
 - iii. Natural Resources Canada, Energy Sector; and
 - iv. Transport Canada.
 - h. The following provincial government ministries, agencies and industrial organizations:
 - i. Ministry of Energy;
 - ii. Ministry of Environment;
 - iii. Ministry of Natural Resources and the Ontario Secretariat for Aboriginal Affairs;
 - iv. All First Nations with an interest in the lands affected by the proposed project
 - v. Ontario Realty Corporation;
 - vi. Ministry of Transportation;
 - vii. Ministry of Government Services;
 - viii. Ministry of Attorney General;
 - ix. Electrical Safety Authority; and
 - x. Independent Electricity Market Operator.
2. To immediately have the Notice published, headed with the Ontario Government logo and the words "Ontario Energy Board" in one issue of the local newspaper having the highest paid circulation in each of the municipalities listed below, according to the best information available:
- i. City of Woodstock
 - ii. Town of Ingersoll
 - iii. Township of Norwich
 - iv. Township of South-West Oxford

NOTE: Please make it clear to each newspaper that the invoice regarding publication is to be sent to Hydro One Networks Inc., not to the Board.

3. To file with the Board affidavit evidence proving the above service and publication immediately upon completion, with the relevant Notices, Application, and original post office registration receipts (where applicable), or courier confirmation lists attached as appendices.

It is not necessary for the affidavits of publication to have newspaper tear sheets attached.

4. To immediately, or as soon as it is ready, have completed copies of the information package and any additional material, as they are developed, and the Application made available for convenient public perusal at Hydro One Networks Inc.'s head office and other offices identified in the Notice, and to post all such documents on Hydro One Networks Inc.'s web site.
5. To immediately provide copies of the information package and any additional material, as they are developed, and the Application to the offices of the municipalities listed in the Notice, and to request them to make such documents available for convenient public perusal.
6. To immediately provide a copy of the Application to any person upon request.
7. To immediately supply a copy of Hydro One Networks Inc.'s information package and any additional material, as they are developed, to any person upon request.
