I AM A SENIOR WHO HAS LIVED IN MY PRESENT HOME FOR OVER 39 YEARS. THIS IS AN ALL-ELECTRIC HOME, NO DUCTS, EACH ROOM HEATED BY AN ELECTRIC BASEBOARD HEATER, AND EACH ROOM HAS IT'S OWN THERMOSTAT. IT'S A SMALL SEMI-DETACHED HOUSE WITH 3 BEDROOMS, A SMALL COMFORTABLE PLACE WE HAVE CALLED HOME FOR ALMOST 4 DECADES. THE INCREASING COST OF ELECTRICITY IS CAUSING US CONCERN NOW THAT WE ARE IN OUR '70'S AND SPEND MOST OF OUR TIME AT HOME.

I HAVE MONITORED MY CONSUMPTION AND COST OF ELECTRICITY SINCE 1972, GETTING MORE DETAILED AS COSTS ROSE - 1973/4 - 12%, 1974/5 - 21%, - 1975/6 - 15%, 1976/7 - 22% - AS AN EXAMPLE. OVER THE PERIOD FROM 1972 TO 2006 I REDUCED MY CONSUMPTION BY 31%. (23,800 KW IN 1972 TO 16,408 IN 2006). MY TOTAL COST FOR 2006 WAS \$1,724.07 (IN 1972 I PAID \$292.23!!)

WITH ESCALATING COSTS EVERY YEAR, AS LOW INCOME SENIORS WHO DEPEND ON HEATING OUR HOMES IN THE WINTER, WE WONDER IF THE FUTURE IN ONTARIO WILL SHOW THAT ELECTRICITY WILL BE AFFORDABLE FOR ONLY THE WEALTHY IN OUR SOCIETY, REDUCING THE POOR AND SENIORS ON A FIXED INCOME TO THIRD WORLD STATUS. I HAVE NO E-MAIL OR COMPUTER. THIS IS MY COMMENTS ONLY. Thank you, yours sincerely,
