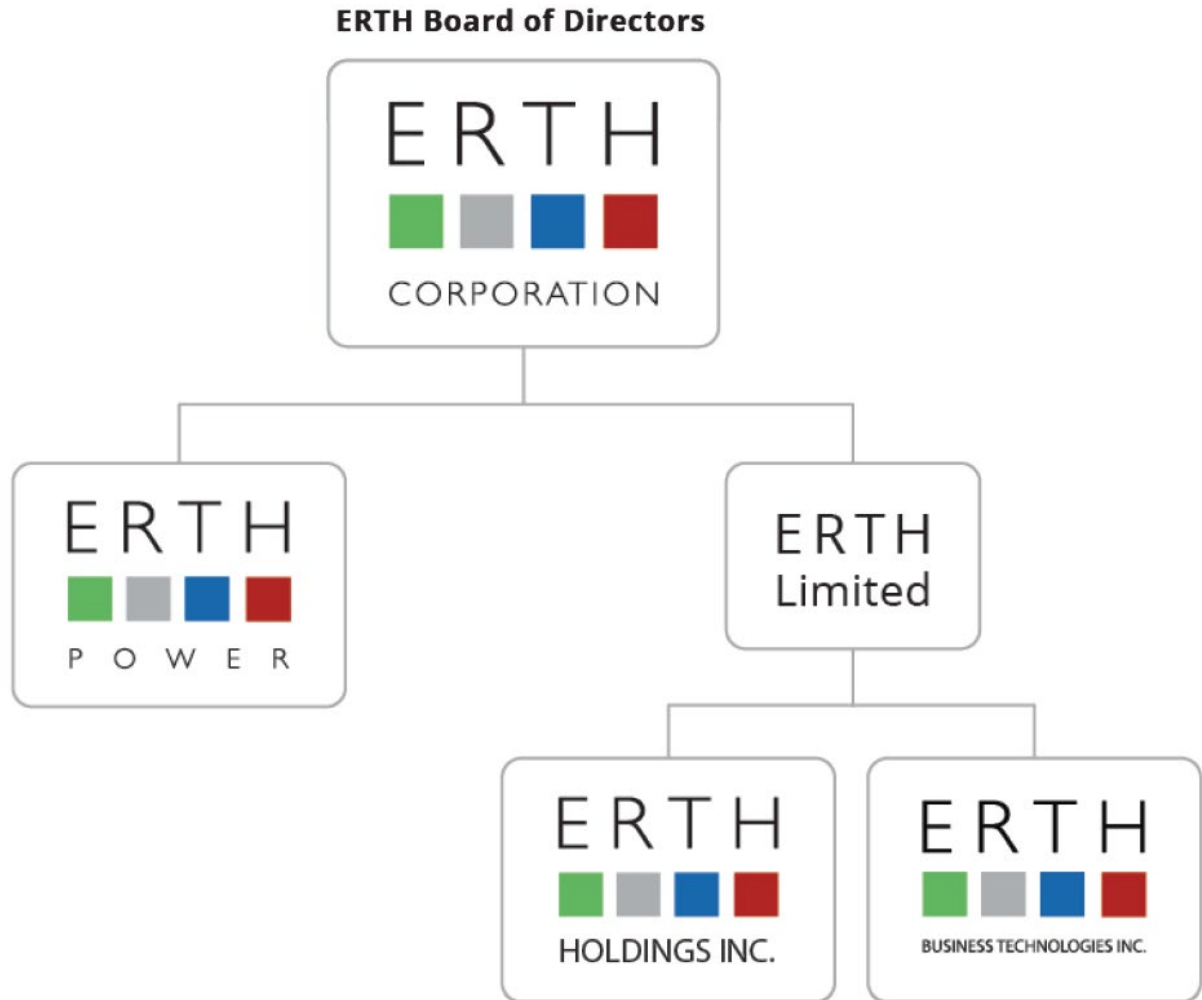

This exemption expires April 1, 2009.</i></p> <p>3. <i>The Licensee is exempt from the requirement for meter enrollment testing as of the mandatory date for time-of-use pricing for RPP consumers with eligible time-of-use meters as required under the Standard Supply Service Code for Electricity Distributors. This exemption expires February 28, 2011.</i></p> <p><i>ERTH Power notes that all of the exemptions above are no longer necessary and may be removed from its distribution license.</i></p>
