



Enbridge Gas Inc.

Application for leave to construct natural gas pipeline and associated facilities in the Municipality of Chatham Kent and Municipality of Lakeshore

PROCEDURAL ORDER NO. 6

July 28, 2023

Enbridge Gas Inc. (Enbridge Gas) originally applied to the Ontario Energy Board (OEB) on June 10, 2022, under sections 90 and 97 of the *Ontario Energy Board Act, 1998*, S.O. 1998, c. 15, (Schedule B), for an order granting leave to construct a project which included approximately 19 kilometres of natural gas pipeline from its Dover Transmission Station in the Municipality of Chatham Kent to its existing pipeline in the Municipality of Lakeshore (Panhandle Loop) and approximately 12 kilometres of natural gas pipeline in the Municipality of Lakeshore, Town of Kingsville and the Municipality of Leamington (Leamington Interconnect). The project also involved valve site station work required to tie in the proposed pipelines. Enbridge Gas also applied to the OEB for approval of the form of land-use agreements it has or will offer to landowners on the route of the project.

On December 5, 2022, on the date Enbridge Gas was due to file its argument-in-chief, Enbridge Gas advised the OEB that, due to unexpected circumstances, it was not in a position to file its argument-in-chief by the deadline established in Procedural Order No. 3. Enbridge Gas requested that the OEB place the application in abeyance. In Procedural Order No. 4, dated December 14, 2022, the OEB approved Enbridge Gas's request to place the application in abeyance as of December 5, 2022.

On June 16, 2023, Enbridge Gas filed its amended application. In the amended application, Enbridge Gas stated that it reassessed the project and decided to remove the Leamington Interconnect. Enbridge Gas also updated the project demand forecast, project construction and in-service schedules, the costs and economics and the other evidence affected by the changes in the project's scope, schedule and costs.

Determination on Abeyance Status

The OEB reviewed the amended application and determined that it is complete and complies with the filing requirements set in the *OEB Natural Gas Facilities Handbook* and *OEB Rules of Practice and Procedure*.

The OEB, in Procedural Order No. 4, directed that Enbridge Gas address the applicability of EBO 134 and EBO 188 in its amended application, and the extent to which contributions in aid of construction should be required. The OEB directed that Enbridge Gas provide additional evidence on these issues. The OEB also noted that Enbridge Gas may wish to consider whether it should communicate with potentially affected customers regarding the position of some parties that contributions in aid of construction should be required. In response to the OEB's direction, Enbridge Gas included in the amended application updated evidence on these matters.

The OEB will resume processing the application.

Amended Notice of Application

Enbridge Gas is directed to conduct a search of title to identify any new landowners owning the properties or interest in properties and any new encumbrances since the Notice of Application was served on July 4, 2022. The OEB directs Enbridge Gas to serve the English and French versions of the amended Notice of Application on any identified new directly affected landowners along the proposed route of the Panhandle Loop.

The English and French versions of the amended Notice of Application are attached as Schedule A and B to this procedural order.

Request for Confidentiality

Enbridge Gas has requested confidential treatment for personal information in the Environmental Report (Exhibit F/Tab 1/Schedule 1/Attachment 1) and in the Landowner List (Exhibit G/Tab 1/Schedule 1/Attachment 2).

The OEB has reviewed Enbridge Gas's request for the redaction of personal information. The OEB finds that the redacted information in the Environmental Report (Exhibit F/Tab 1/Schedule 1/Attachment 1) and in the Landowner List (Exhibit G/Tab 1/Schedule 1/Attachment 2) is personal information as defined in the Freedom of Information and Protection of Privacy Act (FIPPA) and the OEB's [Practice Direction on Confidential](#)

[Filings](#) (Practice Direction). This information, which contains names and contact information of property owners, shall remain redacted and shall not be provided to the intervenors in this proceeding.

Next Steps

This procedural order establishes the timeline for written interrogatories, a virtual technical conference, Enbridge Gas's argument-in-chief, written submissions by the parties and a reply submission by Enbridge Gas.

At this time, provision is being made for written interrogatories. In preparing their interrogatories, parties should refer to the OEB's [standard Issues List](#) for natural gas leave to construct applications. Parties should also consult sections 26 and 27 of the OEB's [Rules of Practice and Procedure](#) regarding required naming and numbering conventions and other matters related to interrogatories.

To allow for an efficient discovery process, Enbridge Gas shall advise the OEB and parties, prior to the filing of written interrogatories, the interrogatory and undertaking responses currently on the record that are out of date or no longer applicable as a result of Enbridge Gas's amended application.

The OEB is also making provision for a transcribed technical conference for parties to ask clarification questions on the amended application and evidence. Parties are required to file their questions or topic areas for questioning in advance of the conference. Parties are expected to work cooperatively to avoid duplication and to ensure the time reserved for the technical conference is used effectively. Information on how to participate in the technical conference will be provided at a later date.

The OEB directs that discovery should be focused only on the updated evidence.

The procedural order will also set the timeline for argument-in-chief and written submissions.

It is necessary to make provision for the following matters related to this proceeding. Further procedural orders may be issued by the OEB.

THE ONTARIO ENERGY BOARD ORDERS THAT:

1. The English and French versions of the amended Notice of Application (Notice) attached as Schedule A and B of this procedural order shall be served on any new directly affected landowners along the proposed route of the Panhandle Loop

who were not previously served the Notice of Application issued on July 4, 2022. Enbridge Gas shall:

- a) Conduct a search of title forthwith, sufficient to determine the current registered property owners and encumbrancers with lands or interest in the lands directly affected by the application.
- b) Identify, based on the current search of title, any new registered property owners and encumbrancers with lands or interest in the lands directly affected by the application and not served the Notice of Hearing issued on July 4, 2022.
- c) Arrange immediately for the service of the enclosed English and French versions of the Notice, in the exact form accompanying this letter, and the application and the evidence, directly on each of the property owners and encumbrancers with lands or interest in lands identified in the search of title referred to in paragraph 1 (a) above.

Please note that you must comply with the directions in paragraphs 1 (a), (b) and (c) above prior to **August 9, 2023**. If you are unable to comply with the directions within this timeframe, you must inform the Registrar immediately at registrar@oeb.ca.

2. Enbridge Gas shall advise the OEB and all the intervenors which of the interrogatory and undertaking responses currently on the record are incorrect and/or no longer applicable as a result of Enbridge Gas's amended application by, **August 25, 2023**.
3. OEB staff and intervenors shall request any relevant information and documentation from Enbridge Gas that is in addition to the updated evidence already filed, by written interrogatories filed with the OEB and served on all parties by, **September 11, 2023**.
4. Enbridge Gas shall file with the OEB complete written responses to all interrogatories and serve them on intervenors by, **September 26, 2023**.
5. A transcribed technical conference with a focus on updated evidence will be convened on **October 10, 2023** beginning at 9:30 a.m. Information on how to participate in the conference will be communicated at a later date.

6. Parties intending to participate in the technical conference shall file with the OEB and copy all parties, their clarification questions or the topic areas for which they require clarification by **September 29, 2023**.
7. Enbridge Gas shall file with the OEB complete written responses to all undertakings from the technical conference and serve them on all intervenors by **October 17, 2023**.
8. Enbridge Gas shall file its argument-in-chief with the OEB and serve it on all intervenors by **October 31, 2023**.
9. OEB staff and intervenors shall file their written submissions with the OEB and serve them on all parties by **November 15, 2023**.
10. Enbridge Gas shall file a written reply submission, if any, with the OEB and serve it on all intervenors by **November 29, 2023**.

Parties are responsible for ensuring that any documents they file with the OEB, such as applicant and intervenor evidence, interrogatories and responses to interrogatories or any other type of document, **do not include personal information** (as that phrase is defined in the *Freedom of Information and Protection of Privacy Act*), unless filed in accordance with rule 9A of the OEB's [Rules of Practice and Procedure](#).

Enbridge Gas Inc. has applied for approval to construct approximately 19 kilometres of natural gas pipeline and ancillary facilities, in the Municipality of Chatham Kent in the Municipality of Lakeshore



Enbridge Gas Inc. applied to the Ontario Energy Board for approval to construct pipeline and associated ancillary facilities, which are collectively referred to as the Panhandle Regional Expansion Project. The pipeline, called the *Panhandle Loop*, involves the construction of approximately 19 kilometres of 36-inch diameter steel pipeline that will originate at Enbridge Gas Inc.'s existing Dover Transmission Station in the Municipality of Chatham Kent and tie into an existing pipeline at a new valve site station, in the Municipality of Lakeshore. Enbridge Gas Inc. proposes to start construction of the Panhandle Regional Expansion Project in the first quarter of 2024 to achieve an in-service date of November 2024.

Enbridge Gas Inc. says that the Panhandle Regional Expansion Project is needed to add capacity to the Panhandle Transmission System which transports natural gas between Enbridge Gas Inc.'s Dawn Compressor Station, located in the Township of Dawn-Euphemia, and the Ojibway Valve Site, located in the City of Windsor. Enbridge Gas Inc. estimates the cost of the project to be \$358 million and says that it will seek approval to recover the cost from ratepayers in a separate rate application.

Enbridge Gas Inc. is also asking the Ontario Energy Board to approve the form of agreement it offers to landowners to use their land for routing or construction of the proposed pipeline.

The location of the proposed pipelines is shown in the map.



THE ONTARIO ENERGY BOARD WILL HOLD A PUBLIC HEARING

The Ontario Energy Board (OEB) will hold a public hearing to consider Enbridge Gas's application. During the hearing the OEB will question Enbridge Gas on the case. The OEB will also hear questions and arguments from individual consumers, municipalities and others whose interests would be affected. At the end of this hearing, the OEB will decide whether to approve the application.

As part of its review of this application, the OEB will assess Enbridge Gas's compliance with the OEB's *Environmental Guidelines for the Location, Construction and Operation of Hydrocarbon Pipelines and Facilities in Ontario*.

The OEB will also assess whether the duty to consult with Indigenous Communities potentially affected by the proposed pipelines has been discharged with respect to the application.
