### Mandate and Objectives:

PERIMETER FOREST LIMITED PARTNERSHIP, by its general partner, PERIMETER FOREST GP INC. owns and manages some 147,000 acres of forestland through which the Hydro One transmission corridor under consideration traverses our property.

Perimeter Forest maintains an extensive road system throughout our "Painted Forest" property, and we wish to work collaboratively with Hydro One to ensure our road system is not negatively impacted or modified. Excessive traffic or modifications to our roads to accommodate increased traffic and heavy equipment will result in additional operational costs to Perimeter Forest. Additionally, we host some 240 recreational lease holders on our property. Road safety and condition is a priority concern for us.

The property is being operated under an improved forest management protocol with intention to foster forest growth to promote carbon sequestration and biodiversity. Cutting or brushing will negatively impact our business model.

Interspersed within our property are a number of gravel pits. We wish to prevent free will access to our aggregate resources.

### Membership of the Intervenor and Constituency

# **Represented:**

Perimeter Forest is the sole landowner with some 240 recreational lease holders that have a vested interest in the property through annual lease payments to PFLP.

### Programs or Activities Carried Out by the Intervenor:

As well as being a conscientious steward of the forestlands and water bodies, Perimeter Forest's business model is to (a) sequester carbon and sell carbon credits, (b) promote biodiversity, and (c) provide recreational enjoyment for 240 lease holders.

Perimeter Forest is a partnership between Perimeter Solar Inc. and the Ontario Teachers' Pension Plan.
