**Re: Guidelines for the Pre-Approval of Long-Term Gas Supply and/or  
Upstream Transportation Contracts ("LTC Guidelines");

The Board has issued a letter to commence a proceeding to review and develop guidelines for the pre-approval of long-term natural gas supply/transportation contracts by Ontario utilities. The file number assigned to this proceeding is EB-2008-0280.


