Interrogatory:

- a) Please reconcile the difference in the charge determinant forecasts for the Line Connection Rate Pool in year 2024 from Table 1 and 2 above.
- b) Based on the answer to part a) above, if applicable, please update the pre-filed evidence in the application.
- c) Based on the answer to part a) above, please provide the 2024 charge determinant forecasts for each Rate Pool to three decimal places.

Response:

- a) The 2024 Line Connection charge determinant is 226,543 MW. The 2024 value in Exhibit A-04-01, Table 5 of this Application was a typographical error.
- b) Although Table 5 of Exhibit A-04-01 contained a typographical error, the calculations in the evidence are based on the Line Connection charge determinants per the Decision and Order, EB-2021-0110, Schedule A, Attachment 1, Schedule 2.1, Table 1b. As such, there are no further updates required.
