INTERVENTION OF ENBRIDGE GAS DISTRIBUTION INC.

1. Enbridge Gas Distribution Inc. ("Enbridge" or the "Company") hereby applies for intervenor status in this proceeding pursuant to the above-captioned matters.
2. Enbridge is a distributor and transmitter of natural gas in Ontario. The supply of natural gas is a vital concern to the Company and its customers.
3. Enbridge has a direct interest in all matters of jurisdiction, substance, and procedure in the regulation of public utilities, and in any decision of the Ontario Energy Board ("Board"), which may create a precedent affecting the Company's own applications.
4. As a cost control measure Enbridge would prefer a written procedure but would accommodate an oral proceeding if that is the preference of the Board and other stakeholders.
5. Enbridge reserves the right to be heard in English, to appear by or with counsel of its choice, to cross-examine on all subject matters in this hearing that may relate to its interests, to adduce evidence on specific matters that are relevant to these proceedings, and to present argument.


