OEB Proceedings:

CCMBC has been granted intervenor status in the following OEB proceedings in the last 24 months:

EB-2022-0002, EB-2022-0079, EB-2022-0013, and EB-2022-0016. It has not been denied intervenor status in any proceeding.

Issues:

Members of the CCMBC are manufacturers and businesses some of whom are customers of Alectra Utilities. The interest of the CCMBC in this proceeding is the impact on its members of the 2024 ICM funding proposed by Alectra. The CCMBC expects to focus on the need for the ICM funding, and in particular the capital expenditures supporting the calculation of the materiality threshold for the determination of the maximum eligible incremental capital for ICM funding.

Policy Interests:

CCMBC has no policy interest in this proceeding.

Hearings:

CCMBC supports Alectra's request for a written hearing.

Evidence:

CCMBC does not intend to file evidence.

Coordination with Other Intervenors:

CCMBC intends to co-ordinate its efforts with other intervenor to avoid duplication by sharing drafts of interrogatory requests and of argument submissions.

Cost Awards:

The CCMBC is a non-profit organization which relies on membership fees and individual donations to help protect the interests of its 418 member manufacturers and other businesses who are all electricity consumers. CCMBC will be requesting an award of costs for its participation in this proceeding and believes that, as a coalition representing the direct interests of electricity consumers, it meets the eligibility criteria set out in the Ontario Energy Board's Rules of Practice and Procedure and its' Practice Direction on Cost Awards.
