Re: EB-2022-0028– EPCOR EEDO 2023 – Cost Claim

We are counsel to the School Energy Coalition (“SEC”). Attached, please find the cost claim using the OEB’s cost claim system.

This proceeding involved a partial settlement reached after a three-day settlement conference, with many of the most significant issues (capital, OM&A, cost of debt, load forecast, certain DVA accounts, and effective date) determined as part of a two-day oral hearing followed by detailed written argument. There was also additional evidence filed by the Applicant precipitated by its amendment to its requested effective date, which resulted in supplementary interrogatories.

SEC divided up responsibility amongst its consultant Jane Scott and counsel Mark Rubenstein. Ms. Scott had primary responsibility of reviewing the application and the written discovery process, whereas Mr. Rubenstein had primary responsibility for the settlement conference negotiations, settlement proposal review, the oral hearing, and preparing the written argument. Senior counsel Jay Shepherd was involved early in this proceeding and was involved in the issues list review and submissions, as well as meeting with the Applicant regarding its amended effective date.

For purposes of cost claim categorization, we have also included time under the ‘Other Attendance’ category for docketed time that does not fall within the other categories (reviewing the Procedural Orders, correspondence regarding schedule, meeting with the Applicant regarding its revised effective date proposal, etc.).

SEC submits that its participation in this proceeding was thorough and valuable and was designed to maximize its assistance to the OEB in this challenging matter. SEC therefore requests reimbursement of its reasonably incurred costs as set forth in the attached cost claim, which is commensurate with the scope of the issues, and the role that it took in this proceeding.
