This correspondence is in response to PP’s August 24, 2023 letter in which PP made comments regarding the reply submissions of Enbridge Gas and the use by PP of evidence references relating to Enbridge Gas’s rebasing proceeding.

Enbridge Gas maintains its position stated in its reply submissions in this regard.<sup>1</sup> As indicated in PP’s August 24, 2023 letter, PP’s intent was to introduce new evidence into the record of this proceeding at the time of final submissions. The OEB has previously found this practice to not be appropriate.

PP also alluded to information that Enbridge Gas provided as part of its reply submissions relating to the environmental reports for the Selwyn Project, MBQ Project, and Hidden Valley Project regarding the presence of bedrock and well water monitoring. The information referenced in paragraphs 34 to 40 of Enbridge Gas’s reply submissions are part of the record of this proceeding, except for the number of letters mailed to owners of private wells to offer participation in a well monitoring program, the number of responses received, and the number of wells sampled in each project area. This data was provided for informational purposes in a manner similar to updates that can occur in submissions regarding, for example, permitting activities and the status of Indigenous consultation, and not to advance a point of argument.
