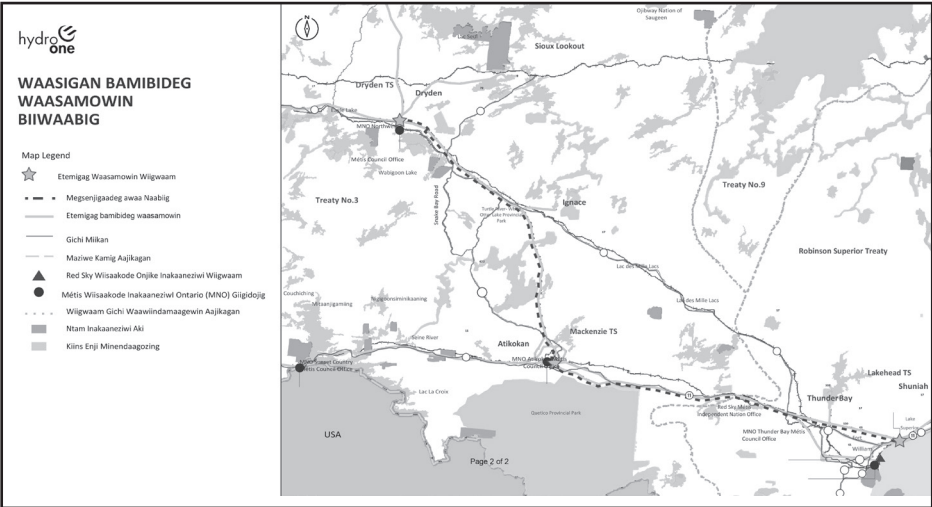

Hydro One Networks Inc.miinwaa age ado gagwejimaan Ontario Waasmowin Nyaagdowaabmdamjig awii minwaabmdaminid owi moshkinebiigan owi bezhigwendamowin bagidinimiwaa-aad aki debendamajig awii nikaaziwaad ado kiimiwaa awi bimaabiig maage zhichigaadeg owi inaakinigaadeg bimaabiigimag waasamowin biiwaabig.

Owi OEW njikegaabwiwog miinwaa gaawii gwayaa wiidookwaasiwan bemaadizijig debendamowaad nakiiwin. Ada ayaanaa-aa bemaadizijig dizhinjigewin awii dibegewendamowaad Hydro One Networks Inc.’s (Hydro One) gagwedwewiniwaan. Epiichi temigag owi dizhinjigewin, owi Ontario Waasmowin Nyaagdowaabmdamjig ada dibegewendaanaa-aa gekendaagwog miinwaa azhidendamowinan owi Hydro One miinwaa waajiyajig (bebezhiig bemaadizijig, odenwinan miinwaa bekaanzijig dibendaasowinan age madookdaagemigag) agaa boozibiigejig awii wiiji yaawaad zhiwe dizhinjigewin (ezhinikaaziwaad nanaagwigaabiwijig). Ekwaasemigag maanda dizhinjigewin, owi Ontario Waasmowin Nyaagdowaabmdamjig ada giizhendami endagwen aji minwaabmdang owi gagwedwewin.

Owi enigokwaag owi Ontario Waasmowin Nyaagdowaabmdamjig inaakinigaadeg bibaamiziwin owi onji gagwedwewinan dowaabmjigaadeg bagidinigewin awii zhichigaadeg bamibideg waasamowin biiwaabig zhisijigaademigag zhiwe bakebiiganan 92, 96, miinwaa 96.1 owi *Ontario Energy Board Act*. Apii debegenjigaadeg endogwen owi inaakinigaadeg nakiiwin aawong bemaadizijig misendamowin, owi *Ontario Energy Board Act* gikidomigad owi Ontario Waasmowin Nyaagdowaabmdamjig goweta ada makwendaanan newen dibendaasowinan gewe gaashpinajigejig owi onji engindemigag miinwaa owi penimandaagwog miinwaa epiichi nishing owi waasamowin anokiwin. Ezhi dowendaagwog zhiwe bakebiigan 97 owi *Ontario Energy Board Act*, owi Ontario Waasmowin Nyaagdowaabmdamjig age ado dibegendaanan ezhiwebak owi e’nowendaagwog owi moshkinebiigan owi bezhigwendamowin bagidinimiwaa-aad aki debendamajig madookidaagaazijig owi bimaabiising maage temigag owi bamibideg waasamowin biiwaabig.

Gichi piitendaagwod awii akinwaadendamong owi Ontario Waasmowin Nyaagdowaabmdamjig ado dizhinjigewin gaawii goweta aawizino minwaabmjigewin nendowendaagwog jibwaa owi bimaabiising waasamowin biiwaabig zhichigaademigag. Aki binaajichigaadeg, maage bibaamendaagwog

e’nowendaagwog owi Gichi Gimaawin ado inaangizhewin awii ginonaawaad Giizhaa Agaa Yaajig bemaadizijig, gaawii digosizino owi Ontario Waasmowin Nyaagdowaabmdamjig ado nda gikenjigewin goweta giishpin temigag gagwek madookidaagewin owi engindeg miinwaa owi penimandaagwog miinwaa epiichi nishing owi waasamowin anokiwin.
