Applications for an Electricity Retailer Licence and a Gas Marketer Licence

### **DECISION AND ORDER**

Summitt Energy Management Inc. on behalf of Summitt Energy LP (Summit Energy) filed two applications on July 17, 2023, with the Ontario Energy Board (OEB). One application, filed pursuant to section 60 of the *Ontario Energy Board Act, 1998* (OEB Act), is for a renewal of Summitt Energy's electricity retailer licence, and the other, filed pursuant to section 50 of the OEB Act, is for a renewal of Summitt Energy's gas marketer licence.

The OEB combined the applications into one proceeding, under section 21(5) of the OEB Act. This Decision and Order is being issued by the Delegated Authority pursuant to Section 6 of the OEB Act. The Delegated Authority has considered the applications without holding a hearing pursuant to section 6(4) of the OEB Act.

On June 21, 2023, Summitt Energy submitted a request to the OEB, to extend the licence term on both the electricity retailer licence ER-2018-0099 and gas marketer licence GM-2018-0100, which expired on June 20, 2023. An Interim Decision and Order extending the licence term to October 1, 2023, was issued on June 22, 2023.

Summitt Energy's applications for renewal of its electricity retailer and gas marketer licences are granted. When evaluating applications for an electricity retailer and gas marketer licences, the OEB focuses its consideration on the requirements set out in *Ontario Regulation 90/99: Licence Requirements - Electricity Retailers and Gas Marketers* under the OEB Act (Regulation). The record in these cases indicates that Summitt Energy has met the requirements set out in the Regulation. The OEB notes the application was filed by the applicant 27 days after the expiration of the existing licenses and takes this opportunity to remind the applicant and all existing licencees that they must ensure their renewal application is filed in time to permit the OEB to undertake its review and issue a licence prior to the expiry of an existing licence.

#### IT IS ORDERED THAT:

- 1. The application for an electricity retailer licence is granted, on such conditions as are contained in the attached licence.
- 2. The application for a gas marketer licence is granted, on such conditions as are contained in the attached licence
