The Ontario Energy Board (OEB) has now issued its Notice of Hearing for Enbridge Gas's application for the Sandford Community Expansion Project (Notice). The Notice will be published by the OEB, in accordance with directions to the OEB's media agent. Please note that you must comply with the directions in paragraphs 1 and 3 below **prior to September 29, 2023**. If you are unable to comply with the directions within this timeframe, you must inform the Registrar immediately at registrar@oeb.ca.

You are directed:

- 1. To conduct a search of title forthwith, sufficient to determine the current registered property owners and encumbrancers with lands or interest in the lands directly affected by the proposed pipeline and related facilities.
- 2. No later than the date the Notice is posted on Enbridge Gas's website in accordance with paragraph 3, to arrange for the service of the enclosed Notice, in the exact form accompanying this letter, and the application and the evidence, directly on each of the following:
 - a. all property owners and encumbrancers with lands or interest in lands identified in the search of title referred to in paragraph 1 above
 - b. the clerk of the Township of Uxbridge and Region of Durham

- all Indigenous communities that have been consulted or with lands or interest in the lands directly affected by the proposed pipeline and related facilities
- d. the Métis Nations of Ontario, Suite 1100 66 Slater Street, Ottawa, ON K1P 5H1
- e. all affected utilities and railway companies
- f. members of the Ontario Pipeline Coordinating Committee
- g. Lake Simcoe Region Conservation Authority
- h. Fisheries and Oceans Canada
- i. Transport Canada
- j. Environment and Climate Change Canada
- k. Indigenous Services Canada
- I. Crown-Indigenous Relations and Northern Affairs Canada
- m. Bereavement Authority of Ontario
- n. Ministry of Public and Business Service Delivery

- p. Ministry of Indigenous Affairs
- q. Impact Assessment Agency of Canada

- 3. To make a copy of the Notice, the application and the evidence, and any amendments thereto, available for public review at Enbridge Gas's office and in a prominent place on Enbridge Gas's website.
- 4. To file with the OEB an affidavit proving completion of the matters in paragraphs 1 through 3 above immediately thereafter, with the relevant Notices and original post office registration receipts (where applicable), or courier confirmation lists attached as appendices.
- 5. To provide a copy of the Notice, the application and the evidence, and any amendments thereto, to anyone requesting the material.

You are further directed not to include any documents or materials when serving the Notice other than documents or materials expressly required by this letter of direction to be served.
