The Ontario Energy Board (OEB) received Provident Energy Management Inc.'s application for an unit sub-metering licence on August 31, 2023. The OEB has assigned file number EB-2023-0266 to the application. The application will be decided by an employee of the OEB who has been delegated this authority pursuant to section 6 of the *Ontario Energy Board Act, 1998* (Delegated Authority). The Delegated Authority intends to make a decision on the application without holding a hearing.

The OEB has preliminary reviewed your application. Your application is currently incomplete and cannot be processed until the following has been filed:

Please provide a description of both Cricket Energy Holdings Inc. and NCP Meter Aggregator GP business activities.

What is the percentage of ownership that both Cricket Energy Holdings Inc. and NCP Meter Aggregator GP have with respect to Provident Energy Management Inc.?

Does Cricket Energy Holdings Inc. have a parent? If so, what is the parent's name?

Does Provident Energy Management Inc. have any affiliates that are licensed OEB entities? If so, please provide a list of the affiliates, including their OEB Licence No.

2. Finance, Section 10, pg. 5:

Please submit audited financial statements for 2022 and 2021 fiscal years, for the applicant or its parent.

The OEB will resume processing your application once the above information has been filed. If the above information is not filed within 30 days of the date of this letter, the OEB may close the file for this application.

Once your application is complete, the Delegated Authority expects to issue a final decision on your application within 60-90 days.

In the event the Delegated Authority decides to deny or otherwise modify the relief you requested in your application, you will be given an opportunity to provide comments. The Delegated Authority will consider your final comments, if any, prior to issuing a decision and order.
