Enbridge has indicated a desire for confidential treatment of certain information in its application, including Confidential Treatment of information in E-1-1 related to project load profiles, energy usage and billing. The OEB will need to assess this specific information since it forms a primary basis for the need and design of the proposed pipeline. Although there could be a confidential process added to the proceeding to deal with these issues, there is insufficient basis to consider this information confidential and it is recommended that the OEB not provide confidential treatment for the information in E-1-1.
