**RE: Consultation on Policy for Standby Rates  
Ontario Energy Board File No. EB-2023-0278**

The Ontario Energy Board (OEB) intends to engage stakeholders to inform its approach to existing and future electricity distribution standby rates, including consideration of the approach to standby rates outlined in the OEB's Commercial and Industrial Rate Design [staff paper](#).<sup>1</sup>

In 2006, the OEB declared existing standby rates interim, citing uncertain costs, and an upcoming review of distribution rate design.<sup>2</sup> In 2011, the OEB invited electricity distributors to apply to have their rates converted to final rates subject to notification of affected customers.<sup>3 4</sup> Currently, 11 electricity distributors have standby rates, seven of which are still on an interim basis. Finalizing the interim rates provides certainty to both distributors and customers.

### **Stakeholder Meeting**

The OEB will host a stakeholder meeting to solicit input from stakeholders regarding current practices with respect to standby rates and to discuss options moving forward. Consideration will be given to the interim nature of some existing rates and approaches for distributors seeking to establish new standby rates. The scope of this consultation is limited to distribution rates for standby service for customer owned load displacement

generation. The OEB has a number of ongoing initiatives addressing distributed energy resources and related matters. The scope of this consultation will therefore not include distributed energy resources or other facilities deployed for any purpose other than load displacement.

The meeting will be scheduled shortly. This session will include discussion of current approaches to standby rates as well as more general discussion around cost causation of standby service, what approaches incent efficient use of the distribution system, and how these are influenced by characteristics of the backup service being provided. For example, size, availability and dispatchability of a resource being backed up by the distributor.

The OEB would welcome presentations by distributors on their circumstances related to standby rates. If you are interested in making a presentation at this first meeting, please contact Andrew Frank at the email address below.

Also planned is a second stakeholder meeting, which will focus on participant recommendations for existing and potential future standby rates. Participants will be advised of the second meeting date in due course. The OEB may also welcome presentations at this meeting as well.

Costs awarded will be recovered from all licensed rate-regulated electricity distributors. Further information regarding cost awards is included in Appendix A to this letter.

## Appendix A Cost Award Matters

### Cost Award Eligibility

The OEB will determine eligibility for costs in accordance with its [Practice Direction on Cost Awards](#). Any person intending to request an award of costs must file with the OEB a written submission to that effect by **October 12, 2023**. The submission must identify the grounds on which the person believes that it is eligible for an award of costs (addressing the OEB's cost eligibility criteria as set out in section 3 of the *Practice Direction on Cost Awards*). An explanation of any other funding to which the person has access must also be provided, as should the name and credentials of any lawyer, analyst or consultant that the person intends to retain, if known. All requests for cost eligibility will be posted on the [OEB's website](#). If a licensed rate-regulated electricity distributor has any objections to any of the requests for cost eligibility, such objections must be filed with the OEB by **October 19, 2023**. Any objections will be posted on the OEB's website. The OEB will then make a final determination on the cost eligibility of the requesting participants.

### Eligible Activities

The eligible activities are as follows:

The maximum hourly rates set out in the Cost Awards Tariff will also be applied.
