

Subject: EB-2008-0272, Cost Eligibility Request of Lewis J Balogh Intervenor.

The purpose of this belated letter is to apply for costs that were and will be sustained by me during the activities of the Board in dealing with matters related to **Hydro One Network's Application for an Electricity Transmission Revenue Requirement Change.**

At the time of my request to be selected as an intervenor, I did not foresee the amount of work that these activities would involve. To fulfill the role of the intervenor however, does take a substantial amount of my time and give rise to out-of-pocket expenses. I regret that my original intent to do this *pro bono* was ill conceived.

I now am respectfully asking the Board to allow my request to go forward.

The rationale for this is as follows: under the terms contained in The Practice and Direction on Cost Awards, I am eligible as stated in section 3.03

- (a) namely I am a member of three agri-business organizations. These are Ontario Corn Producers Association, Soybean Growers of Ontario and The Grape Growers of Ontario, with thousands of members whose rates would be affected;
- (c) I have an interest in lands affected by the process as transmission lines located on lands I own;

I can request costs as I studied the Pre-filed Evidence and as an "intervenor", prepared and submitted interrogatories to the applicant and to the Board to partake in the process;

in section 10.04

I may request cost awards by a letter to the Board.

I did not attach my CV to this as I am partaking as a concerned layman, not as a consultant.
I hope that the foregoing is sufficient to gain approval to my request.
