The Ontario Energy Board (“OEB”) will host a stakeholder meeting to solicit input from stakeholders regarding current practices with respect to standby rates and to discuss options moving forward. The meeting will include general discussion around cost causation of standby service, what approaches incent efficient use of the distribution system, and how these are influenced by characteristics of the backup service being provided. The meeting will be scheduled shortly.
