
I, Jim Hogan, of the Town of Lakeshore, in the County of Essex make oath and say that:



# NOTICE OF A RATE HEARING

## E.L.K. Energy Inc. has applied to change its electricity distribution rates effective May 1, 2024

If the application is approved as filed, a typical residential customer and a typical general service customer of E.L.K. Energy Inc. would see the following increase:

Residential (750 kWh)	\$2.65 per month
General Service less than 50kW (2,000 kWh)	\$4.27 per month

Other customers, including businesses, will also be affected.

The requested rate change is set using an OEB-approved formula, which is tied to inflation and other factors intended to promote efficiency.

In addition, E.L.K. Energy Inc. has applied for incremental capital funding for the purchase of two fleet vehicles and the purchase and installation of six recloser switches. E.L.K. Energy Inc. has also applied to recover the costs (and carrying charges) related to the damage caused to its distribution system by an ice storm and a thunderstorm. The impact of these purchases and the storm cost recovery is reflected in the above-noted bill impacts.

It's important to review the application carefully to determine whether you may be affected by the proposed changes.

**E.L.K. Energy Inc. a déposé une requête en vue de modifier ses tarifs de distribution d'électricité à compter du 1<sup>er</sup> mai 2024**

Si la demande est approuvée telle quelle, la facture d'un client résidentiel type et d'un client de services généraux type de E.L.K. Energy Inc. subirait l'augmentation suivante :

Client résidentiel (750 kWh)	2,65 \$ par mois
Client de services généraux dont la demande est inférieure à 50 kW (2 000 kWh)	4,27 \$ par mois

D'autres clients, notamment les entreprises, seront également touchés.

La demande de changement de tarifs est établie à l'aide d'une formule liée à l'inflation et approuvée par la CEO, ainsi qu'à d'autres facteurs visant à favoriser l'efficacité.

En outre, E.L.K. Energy Inc. a demandé un financement supplémentaire pour l'achat de deux véhicules de flotte et l'achat et l'installation de six interrupteurs de réenclenchement. E.L.K. Energy Inc. a également demandé le recouvrement des coûts (et frais financiers) liés aux dommages causés à son réseau de distribution par une tempête de verglas et un orage. L'impact de ces achats et du recouvrement des coûts de la tempête est reflété dans les montants mentionnés ci-dessus.

Il est important d'examiner la requête attentivement afin de déterminer si vous serez concernés par les changements proposés.
