#### **DECISION AND ORDER**

On September 5, 2023, Long Slide Power Inc. (Long Slide) filed a completed application with the Ontario Energy Board (OEB) under section 60 of the *Ontario Energy Board Act,* 1998 (OEB Act) for an electricity generation licence. On September 26, 2023, 851197 Ontario Limited cob Long Slide Power (851197), pursuant to section 77(5) of the OEB Act, requested the OEB cancel its electricity generation licence, EB-2010-0322.

The OEB combined the two matters into one proceeding, pursuant to section 21(5) of the OEB Act. This Decision and Order is being issued by the Delegated Authority without a hearing pursuant to section 6(4) of the OEB Act.

The applicants stated that, 851197 and Long Slide entered into an agreement to sell the generation facility, located at 2923 Highway 630 South, RR#2, Mattawa, Ontario (subject facility) and its related assets, currently owned and operated by 851197, to Long Slide.

Long Slide will be both an owner and the operator of the subject facility, pending completion of sale. It intends to continue all current business activities of 851197, at the subject facility, in a similar manner. Thus, Long Slide has filed an application for an electricity generation licence and 851197 has requested to cancel its electricity generation licence.

The issuance of the electricity generation licence will not materially affect the operation of the subject facility, and Long Slide has demonstrated that it has the technical and financial capacity to operate it.

The OEB finds that it is in the public interest to grant the application and issue an electricity generation licence to Long Slide. However, as the sale of the subject facility has not yet been completed, the OEB's approval in this Decision and Order shall not take effect until Long Slide files written confirmation with the OEB of the closing of the transaction. The OEB will cancel 851197 licences when it receives the written confirmation the transaction has closed from Long Slide.

## IT IS ORDERED THAT:

1. Subject to paragraph 2 below, the application by Long Slide for an electricity generation licence is granted.

2. The electricity generation licence for Long Slide shall be issued and take effect once Long Slide advises the OEB, in writing, that the transaction described in its application, and summarized in the Decision and Order, has closed.
