Issues:

Members of CCMBC are electricity ratepayers. The rates they pay will be impacted by the proposed recovery and rate treatment of differences between actual versus budgeted

construction costs, COVID-19 costs and debt financing costs related to the construction of the East-West-Tie line.

Policy Interests:

CCMBC represents a group of electricity ratepayers and has no specific policy interest in this proceeding.

Hearings:

Coordination with Other Intervenors:
