London Hydro Inc.

Application for electricity distribution rates beginning May 1, 2024

PROCEDURAL ORDER NO. 1 November 21, 2023

London Hydro Inc. (London Hydro) filed an incentive rate-setting mechanism (IRM) application with the Ontario Energy Board (OEB) on October 11, 2023 under section 78 of the *Ontario Energy Board Act*, *1998*, seeking approval for changes to the rates that London Hydro charges for electricity distribution, beginning May 1, 2024.

The OEB issued a Notice of Hearing on November 1, 2023. No persons applied for intervenor status.

It is necessary to make provision for the following matters related to this proceeding. Further procedural orders may be issued by the OEB.

IT IS THEREFORE ORDERED THAT:

- 1. OEB staff shall request any relevant information and documentation from London Hydro that is in addition to the evidence already filed, by written interrogatories filed with the OEB and served on London Hydro, by **December 5, 2023**.
- 2. London Hydro shall file with the OEB complete written responses to the interrogatories by, **January 9, 2024**.
- 3. Any written submissions by OEB staff shall be filed with the OEB and served on London Hydro by **January 23, 2024**.
- Any reply submissions by London Hydro, shall be filed with the OEB by February 6, 2024.

Parties are responsible for ensuring that any documents they file with the OEB, such as applicant and intervenor evidence, interrogatories and responses to interrogatories or any other type of document, **do not include personal information** (as that phrase is defined in the *Freedom of Information and Protection of Privacy Act*), unless filed in accordance with rule 9A of the OEB's <u>Rules of Practice and Procedure</u>.
