Niagara Peninsula Energy Inc. ("NPEI") is in receipt of the Board's Draft Decision and Rate Order in respect of NPEI's 2024 IRM Rate Application (EB-2023-0040).

In accordance with the cover letter, NPEI has reviewed the Draft Decision and Rate Order and has identified several items to bring to the Board's attention, all of which relate to the Draft Tariff of Rates and Charges for the Embedded Distributor Rate Class.

1. NPEI suggests adding the specific installations of the Embedded Distributor Rate Class to the descriptions of the Deferral and Variance Account Rate Riders as follows:

Rate Rider for Disposition of Deferral/Variance Accounts (2024) - effective until December 31, 2024 - Applicable only for Victoria and Rockway installations of the embedded distributor	\$/kW	1.8370
Rate Rider for Disposition of Deferral/Variance Accounts (2024) - effective until December 31, 2024 - Applicable only for Wellandport and Port Davidson installations of the embedded distributor	\$/kWh	0.0025

2. There are two different Rate Riders for Disposition of Capacity Based Recovery ("CBR") Account listed as applicable to the Victoria and Rockway installations. The CBR Rate Riders for the Embedded Distributor Rate Class should be listed as follows:

Rate Rider for Disposition of Capacity Based Recovery Account (2024) - effective until December 31, 2024 Applicable only for Class B Customers - Applicable only for Wellandport and Port Davidson installations of the embedded distributor	\$/kWh	(0.0001)
