2 A1. My name is Ken Schubert and my business address is TransCanada PipeLines
3 Limited, 450 - 1st Street S.W., Calgary, Alberta, T2P 5H1.

4 **Q2. Please state your present position and qualifications.**

5 A2. My current position is Senior Business Analyst, within the TransCanada
6 PipeLines Limited ("TransCanada") System Design and Commercial Operations
7 Department. My responsibilities include: providing recommendations and
8 coordinating projects regarding commercial and operational matters, working
9 with industry collaborative groups to resolve issues, assisting in the preparation of
10 regulatory submissions, and representing TransCanada's interests at NAESB
11 ("North American Energy Standards Board").

12 I joined TransCanada in 1997 in the Gas Accounting Department, which became
13 the Customer Service Department. Since then, I have worked in various roles
14 within Customer Service and this has evolved into my current position. Prior to
15 joining TransCanada, my experience included technical and marketing activities
16 within the energy industry in Calgary.

1 I graduated from the University of Alberta in 1980 with a Bachelor of Science
2 degree in Electrical Engineering. I am a member of the Association of
3 Professional Engineers, Geologists and Geophysicists of Alberta.

1 **Q1. Please state your name and business address.**

2 A1. My name is Stefan (Steve) Pohlod and my business address is TransCanada
3 PipeLines Limited, 450 – 1st Street S.W., Calgary, Alberta.

4 **Q2. Please state your present position and qualifications.**

5 A2. My current position with TransCanada PipeLines Limited (“TransCanada”) is
6 Vice President, Commercial East. I am responsible for meeting the commercial
7 needs of customers as well as managing stakeholder negotiations, industry
8 settlements and the financial performance of the Canadian Mainline.

9 I have been employed by TransCanda since 1988, when I joined with Western
10 Gas Marketing Limited, then a subsidiary of TransCanada as Regional
11 Supervisor, Gas Supply. Prior to my current position, I held positions as Director,
12 Market Development, as well as Senior Vice President, Gas Supply, with
13 TransCanada Gas Services Limited and Director, Europe, with TransCanada
14 International, both subsidiaries of TransCanada.

15 I received a Bachelor of Science degree in Engineering from McGill University in
16 1979.

6 Gas Pipeline Inc. Application for Facilities), RH-1-2007 proceedings, and on
7 behalf of Trans Québec & Maritimes Pipeline Inc. in the RH-1-2008 proceeding.
8 I have appeared as a witness before the Joint Review Panel for the Mackenzie Gas
9 Project (GH-1-2004), and I have also appeared before the Alberta Energy and
10 Utilities Board (“EUB”) as a witness for NOVA Gas Transmission Ltd.
11 (“NGTL”) in respect of the Application for Approval of Costs for Delivery
12 Service to the Fort McMurray Area (EUB Proceeding No. 2001084), the EUB’s
13 2004 Generic Cost of Capital Proceeding (EUB Proceeding No. 1271597),
14 NGTL’s 2004 General Rate Application – Phase 1 (EUB Application No.
15 1315423), NGTL’s 2004 General Rate Application – Phase 2 (EUB Application

2 A1. My name is Tim Stringer and my business address is TransCanada PipeLines
3 Limited, 55 Yonge Street, Toronto, Ontario.

4 **Q2. Please state your present position and qualifications.**

5 A2. My current position is Manager, Commercial East, with responsibility for Sales
6 and Marketing activities as they pertain to markets in Eastern Canada and the
7 Northeastern United States.

8 I have been employed with TransCanada PipeLines Limited (“TransCanada”) since 1991, when I joined the Information Systems group in TransCanada’s
9 Calgary office. Subsequently, I worked in the Gas Accounting (now referred to
10 as Customer Service) and Volume Planning teams. Following the merger of
11 TransCanada and Nova Gas Transmission Limited (“NGTL”), I joined the Sales
12 and Marketing group where I have worked with customers on both the Canadian
13 Mainline and Alberta Systems. In 2003 I transferred to TransCanada’s Toronto
14 office, with my focus being the Eastern Canadian and U.S. Northeast markets.
