Re: EB-2023-0015 Enova Power Corp. Application for 2024 Rates

The above referenced application is being processed by the Ontario Energy Board (OEB) by delegated authority, without a hearing. On December 1, 2023, Enova Power Corp. (Enova) was provided with a draft of the OEB's Decision and Rate Order and Tariff of Rates and Charges.

By letter dated December 7, 2023, Enova provided its comments on the draft, identifying that certain rate generator values do not match with the values set out in the draft Tariff. Enova noted that the issue affects both of its rate zones.

Specifically, for the Kitchener-Wilmot rate zone the following table sets out the values in the draft Tariff (which are incorrect) versus the values set out in the rate generator (which are correct). :
