Issues:

The Consumers Council of Canada is materially impacted by the application as it represents residential consumers of electricity. At this point our interest is in all of the issues included on the standard list for cost of service proceedings and the issues related to Toronto Hydro's request for a custom rate framework for the period January 1, 2026 to December 31, 2029. Our interest may be narrowed upon a complete review of the evidence and following the interrogatory and technical conference processes.

Policy Interests:

Hearings:

At this point the Council cannot assess whether a written or oral hearing would be best. That determination will follow the interrogatory and technical conference processes.

Evidence:

At this point the Council does not intend to file evidence in this proceeding. The Council will be in discussions with other intervenors regarding the filing evidence.

Coordination with Other Intervenors:

The Council regularly coordinates with other intervenors in OEB proceedings and will continue to do so in this case.

Cost Awards:

The Council is seeking cost award eligibility and recovery of its reasonably incurred costs. The Council will be unable to participate in the absence of a cost award. The Council has participated in many electricity rate applications over many years and has been found eligible for cost awards for all of those applications. The Council has also participated in all of the previous rate applications filed by Toronto Hydro.
