# AFFIDAVIT

I am the President of Innisfil Hydro Distribution Systems Limited (the “Company”), a company incorporated under the laws of the Province of Ontario and licensed by the Ontario Energy Board (the “Board”) under the *Ontario Energy Board Act, 1998* as an electricity distributor, and have knowledge of the matters pertaining to this Affidavit.
