This letter acknowledges receipt of your application for a gas marketer licence. The Board has assigned File Number EB-2008-0293 to this matter. Please refer to this number in all future correspondence to the Board regarding this matter.

Your application is currently incomplete and cannot be processed until the following has been filed:

1. Section C12 – The financial information section of the application form requires the applicant to provide information that indicates the applicant's financial state of affairs. Please provide audited financial statements for 2007 and 2006 if audited 2008 financial statements are not ready.
2. Section B8 – The licensing history section of the application requires the applicant to answer whether the applicant or an affiliate has marketed or sold electricity or natural gas in any other jurisdiction. Energy Advantage Inc. has answered "No" to this question. In Section C10, the applicant has stated that it operates Energy Advantage Corp. in Delaware and that it is a similar business to Energy Advantage Inc. Please provide clarification and licensing details if necessary.

The Board will resume processing your application once the above information has been filed. If the above information is not filed within 30 days of the date of this letter, the Board may close the file for this application.

Upon receipt of the required information the Board will issue an acknowledgement letter indicating the expected date on which a decision and/or order may be rendered.

The Board also notes that there is some additional information typically asked for in a licence application. It includes the following:

Section D14 – With reference to information on key individuals section of the application, please provide copies of two pieces of identification, one of which must include a photo. The information is necessary for the Board to conduct a police record check with the Ontario Provincial Police on the key individuals reported in Section D of the application.

There is no expectation that this additional information is needed to begin the process of reviewing this application. However, by providing such information at the same time as the required information, the processing of this application can be expedited.
