PROCEDURAL ORDER NO. 1

Enbridge Gas Distribution Inc. ("Enbridge" or "the Applicant") has filed an application with the Ontario Energy Board (the "Board"), dated June 27, 2008, under section 90(1) of the *Ontario Energy Board Act, 1998*, S.O. 1998, c.15 (Schedule B).

Enbridge has applied for an order of the Board for leave to construct approximately 2.9 km of 12" diameter nominal pipe size (NPS) 12 high pressure steel pipeline and a gate station in order to provide natural gas service to a proposed cogeneration power station of Thorold Cogen L.P. located at the Abitibi pulp mill in the City of Thorold, Ontario.

Notice of Application for the Leave to Construct Application was served and published as directed by the Board. There were three intervenors and one observer. The list of intervenors and their addresses are listed at the end of this Order.

The Board has determined that it is necessary to make the following provisions related to this proceeding:

THE BOARD ORDERS THAT:

1. An intervenor or Board staff who wish information or material that is in addition to the Applicant's evidence, and that is relevant to the Application, shall request the same by written interrogatories filed with the Board and delivered to all intervenors on or before September 10, 2008.
2. Responses by the Applicant to the interrogatories shall be filed with the Board and delivered to all intervenors on or before September 24, 2008. All interrogatories must include a reference to the section of the Application on which the interrogatory is based.
3. An intervenor or Board staff may file a written submission with the Board and delivered to all intervenors on or before October 8, 2008.
4. The applicant may file a reply submission with the Board and delivered to all intervenors on or before October 15, 2008.

All filings to the Board must quote file number EB-2008-0065, be made through the Board's web portal at www.errr.oeb.gov.on.ca, and consist of two paper copies and one electronic copy in searchable / unrestricted PDF format. Filings must clearly state the sender's name, postal address and telephone number, fax number and email address. Please use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at www.oeb.gov.on.ca. If the web portal is not available you may email your document to BoardSec@oeb.gov.on.ca. Those who do not have internet access are required to submit all filings on a CD or diskette in PDF format, along with two paper copies. Those who do not have computer access are required to file 7 paper copies.
