AS IT AFFECTS FARMLAND PROPERTY OF MRS. HERONDINA P. TAVARES AT 1981 MICHIGAN ROAD, SARNIA, ON. – PLAN 7 PT LOT 1 CON 8 PT LOT 11.

Dear Ms. Walli, Mr. Thatcher, Mr. Redford, Mr. Smith:

Mrs. Herondina Tavares via her son Mr. Paul G. Tavares and daughter Mrs. Louise M. Love (with contact information provided below) requests that they receive documents issued by the Ontario Energy Board in the proceeding of Market Hub Partners Management Inc. and Altagas Ltd.on behalf of Sarnia Airport Storage Pool Limited Partnership who filed applications with the Board dated December 31, 2007.

Mrs. Tavares' farmland property and buildings at 1981 Michigan Road, Sarnia, ON – Plan 7 Pt Lot 1 Con 8 Pt Lot 11 – are affected by the proceeding.

She has a number of comments/questions/concerns which are identified below and that she would appreciate consideration in replies.

- 1. On the map titled "Sarnia Airport Gas Storage Project" which shows a proposed pipeline running along Michigan Line, Waterworks Road, Churchill Road, and Mandaumin Road it is not clear which properties are actually affected by the pipeline. Is 1981 Michigan Road a property through which an easement is required for the proposed transmission pipeline? If so, the following questions are asked:
  - 1. Where exactly is this pipeline expected to be located on her property?
  - 2. How close to the current buildings on her property is the pipeline proposed to be located?
  - 3. Can she be satisfied that there is utmost safety of the residents living on the property with the proposed pipeline put in its place?
  - 4. What does this overall project do to the market value of the property? She expects a property appraisal before and after the project completion by a reputable and knowledgeable appraiser to assure her of at least no reduction in the market value of her property.
  - 5. Will she be permitted to erect new buildings on her property near the current buildings and/or anywhere else on her property after this proposed project is complete?
  - 6. Will she be permitted to make additions to the current buildings on her property after this proposed project is completed?
  - 7. Has the Beatty-Craig Drain Project in progress with the Corporation of the City of Sarnia affecting 1981 Michigan Road been taken into consideration into how it will affect the wells and pipelines projects? The ditch runs along the front of Mrs. Tavares' property.
  - 8. Do you bring the property fully to its current condition without any costs to Mrs. Tavares with the completion of this proposed project? Examples: fully restore trees, grass, shrubs, drainage tiles on the farmland, ditch, driveway, culvert to their current conditions.
  - 9. What amount will I receive in compensation for the inconvenience of this proposed project that affects her property?
  - 10. Are any wells proposed to be built on her property? Mrs. Tavares does not approve that there be any wells be built on her property. She does not approve that any pipelines cross onto the farmland crops acreage.
- 2. In regards to the Applications for Well Licenses as listed above, it is to be brought to your attention that:
  - 1. Mrs. Tavares does not approve that there be any pipelines built on her property at 1981 Michigan Road. There are to be no pipelines crossing the farmland acreage that has crops on it. Drainage tiles were installed by Mr. Luis Tavares and Mrs. Herondina Tavares and do not want them damaged.

There is also the concern that the farmland will be damaged indefinitely from its ability to produce the abundance of its crops. The market value of the property would, no doubt, reduce substantially with pipelines crossing the farmland. Mrs. Tavares also wants to be able to erect new buildings on her property in the future and is concerned that the proposed projects would negate her being able to do this.

- 2. Mrs. Herondina Tavares does not approve that there be any wells built on her property at 1981 Michigan Road. See 1. just above for her concerns.
- 3. The letter from Mr. Jim Redford and Mr. Max Fantuz titled "Ontario Energy Board" with a further title of "Sarnia Airport Storage Pool Project" makes mention of "Schedule A", "Schedule "B", "Schedule C". Mrs. Tavares and Mr. Paul Tavares did not receive these documents. Please mail or e-mail copies of them immediately to Mr. Paul Tavares and Mrs. Louise Love for review and then further comments respecting the application.
