Ladies and Gentlemen:

This will acknowledge the receipt of a Notice of Applications issued by the Ontario Energy Board (the "Board") under date of February 14, 2008, with respect to applications filed on behalf of Sarnia Airport Pool Limited Partnership (the "Partnership") for development of the Sarnia Airport Gas Storage Pool Project. The Notice was forwarded to me by Mr. J. Redford of Market Hub Partners Management Inc. It was delivered to my residence at 116 Saint Andrews Drive, St. Simons Island, Georgia, U. S. A., via DHL Express on February 22, 2008.

Attached to the Notice were copies of:

- The initial three pages of a 28 December 2007 application by Market Hub, on behalf of the Partnership, to Ontario Energy Board for authority to develop and operate the above-referenced gas storage pool;
- Four related well license applications filed at various dates in December, 2007 and January, 2008 with the Ontario Ministry of Natural Resources.

Pursuant to the procedure outlined in the Notice of Applications, I wish to request intervenor status in the proceedings under File No. EB-2008-0002. Intervenor status is requested because I hold an overriding royalty interest of 2.5 percent on a 25 percent working interest on each of the P&NG leases in the Sarnia Airport Pool, and I expect to seek recovery from the applicant Partnership of my share of the fair market value of the residual gas reserves in the Pool. I received my interest by assignment from Spelman Prentice under date of 16 December, 1988, effective as of 1 January, 1982, and all such instruments of assignment were registered in the land records of Lambton County in 1989.

My preference is for a written hearing, because of my distant location, far from Sarnia. I do not expect to seek recovery of costs from the applicant.

By copy of this letter to Mr. Redford, I am requesting copies of the Schedules A, B and C that were attached to the Market Hub application of 28 December, 2007, but were not attached to the copy forwarded to me. In addition, I hereby request copies of relevant documents pertaining to the residual gas reserves remaining in the Pool, and as to the intended manner of compensation of the parties holding interests in those reserves.
