Lagasco Inc.

Application for a certificate of public convenience and necessity to construct facilities and supply natural gas to the Proplant Propagation Services Ltd plant located in Haldimand County, Ontario

PROCEDURAL ORDER NO. 1

January 29, 2024

Lagasco Inc. (Lagasco) filed an application with the Ontario Energy Board (OEB) on November 24, 2023, under section 8 of the *Municipal Franchises Act, 1990* for an order granting Lagasco a certificate of public convenience and necessity (certificate) to construct facilities and supply natural gas to the Proplant Electric Generation Facility located at 2401 Highway 6 in the community of Jarvis, Haldimand County, Ontario.

A Notice of Hearing was issued on December 21, 2023. Enbridge Gas Inc. (Enbridge Gas) applied for intervenor status.

No objection was received from Lagasco.

Enbridge Gas Inc. (Enbridge Gas) is approved as an intervenor. The list of parties in this proceeding is attached as Schedule A to this Procedural Order.

It is necessary to make provision for the following matters related to this proceeding. Further procedural orders may be issued by the OEB.

IT IS THEREFORE ORDERED THAT:

- 1. OEB staff and intervenors shall request any relevant information and documentation from Lagasco that is in addition to the evidence already filed, by written interrogatories filed with the OEB and served on Lagasco and all other parties by **February 7, 2024**.
- 2. Lagasco shall file with the OEB complete written responses to the interrogatories and serve them on all intervenors by **February 16, 2024**.
- 3. Any written submissions by OEB staff and intervenors shall be filed with the OEB and served on all other parties by **March 1, 2024**.
- 4. Lagasco may file a written reply submission with the OEB and serve it on intervenors by **March 15, 2024**.

Parties are responsible for ensuring that any documents they file with the OEB, such as applicant and intervenor evidence, interrogatories and responses to interrogatories or any other type of document, **do not include personal information** (as that phrase is defined in the *Freedom of Information and Protection of Privacy Act*), unless filed in accordance with rule 9A of the OEB's <u>Rules of Practice and Procedure</u>.
