The Ontario Energy Board (OEB) has now issued its Notice of Hearing for OPG's Market Renewal Program and Disposition of Deferral & Variance Accounts application (Notice). 2. To serve a copy of the English and French versions of the Notice, the application and the evidence, directly on all intervenors of record in OPG's previous payment amounts proceeding, EB-2020-0290.
3. To post the following message if OPG has an X (formerly Twitter), Facebook, and/or Instagram account:

- a) “We have applied to @OntEnergyBoard to dispose of the balances of certain deferral and variance accounts and for changes relating to impacts from the IESO’s Market Renewal Program.”
- b) « Nous avons déposé une demande auprès de @OntEnergyBoard pour disposer des soldes de certains comptes de report et d’écart, et pour des changements relatifs au Programme de renouvellement du marché de la SIERE. »

The posts are required to include the big box ad and to provide a link to the Notices as posted on OPG’s website in accordance with paragraph 1. Please tag @OntEnergyBoard on X when posting on that social media platform. The OEB does not have a Facebook or Instagram account.

4. To provide a copy of the Notices, the application and evidence, and any amendments thereto, to anyone requesting the material.
5. To file with the OEB an affidavit confirming that the steps set out in paragraphs 1 through 3 have been completed.

You are further directed not to include any documents or materials when serving or publishing the Notices other than documents or materials expressly required by this letter of direction.
