

Elexicon Energy Inc.

**Application for electricity distribution rates and other
charges beginning January 1, 2024.**

**PROCEDURAL ORDER NO. 1
February 06, 2024**

Elexicon Energy Inc. (Elexicon Energy) filed an incentive rate-setting mechanism (IRM) application with the Ontario Energy Board (OEB) on August 16, 2023, under section 78 of the *Ontario Energy Board Act, 1998*, seeking approval for changes to the rates that Elexicon Energy charges for electricity distribution beginning January 1, 2024.

The OEB issued a Notice of Hearing on January 17, 2024. No persons applied for intervenor status.

It is necessary to make provision for the following matters related to this proceeding. Further procedural orders may be issued by the OEB.

IT IS THEREFORE ORDERED THAT:

1. OEB staff shall request any relevant information and documentation from Elexicon Energy that is in addition to the evidence already filed, by written interrogatories filed with the OEB and served on Elexicon Energy by **February 20, 2024**.
2. Elexicon Energy shall file with the OEB complete written responses to the interrogatories by **March 5, 2024**.
3. Any written submissions by OEB staff shall be filed with the OEB and served on Elexicon Energy by **March 19, 2024**.
4. Any reply submissions by Elexicon Energy shall be filed with the OEB by **April 2, 2024**.

Parties are responsible for ensuring that any documents they file with the OEB, such as applicant and intervenor evidence, interrogatories, and responses to interrogatories or any other type of document, **do not include personal information** (as that phrase is

defined in the *Freedom of Information and Protection of Privacy Act*), unless filed in accordance with rule 9A of the OEB's [Rules of Practice and Procedure](#).
