NOTICE OF APPLICATION

On August 14, 2008, Enbridge Gas Distribution (“Enbridge” or the “Applicant”) filed an application seeking an exemption from section 2.2.2 of the *Affiliate Relationships Code for Gas Utilities* (the “ARC”) with respect to the sharing of certain information services with Gazifère Inc., an affiliate of Enbridge, and section 2.2.4 of the ARC with respect to providing certain operational control services to Enbridge Ontario Wind Power L.P., an affiliate of Enbridge (the “Application”).

Section 2.2.2 of the ARC states that, “where a utility shares information services with an affiliate, all confidential information must be protected from access by the affiliate.”

Section 2.2.4 of the ARC states that, “A utility shall not share with an affiliate that is an energy service provider any employee who controls the access to utility services, or directs the manner in which utility services are provided to customers, or who has direct contact with a customer of the utility service.”

The Board has assigned File Number EB-2008-0275 to this application.

Copies of the Application and the pre-filed evidence in support of the Application will be available for public inspection at the Board’s offices and at Enbridge Gas Distribution’s head office.

Enbridge is directed to serve a copy of the application and the Notice via email on all generators and all parties to Board File No. EB-2007-0615 and on Gazifère Inc. and Enbridge Ontario Wind Power LP.

The Board is considering disposing of this proceeding without a hearing pursuant to s.21(4) of the *Ontario Energy Board Act, 1998*, S.O. 1998, c.15, Sched. B (the “Act”) and invites parties to make submissions as to whether the Board should do so. Parties may object by filing a letter of comment with Board. If you object to the Board proceeding without a written hearing, your letter of intervention must include reasons why a written hearing is necessary. Your letter of intervention must be received by the Board within **7 calendar days** from the date of service of this Notice of Application (the “Notice”).

If you already have a user ID, please submit your intervention request through the Board’s web portal at www.errr.oeb.gov.on.ca. Additionally, two paper copies are required. If you do not have a user ID, please visit the Board’s website under e-filings and fill out a user ID password request. For instructions on how to submit and naming conventions please refer to the RESS Document Guidelines found at www.oeb.gov.on.ca, e-Filing Services. The Board also accepts interventions by e-mail, at the address below, and again, two additional paper copies are required. Those who do not have internet access are required to submit their intervention request on a CD or diskette in PDF format, along with two paper copies.
