## Re: InnPower Corporation ("InnPower") - 2024 Cost of Service Application Ontario Energy Board ("OEB") File No. EB-2023-0033 Correction to the Sentinel Light Tariff of Rates and Charges

We write on behalf of InnPower regarding an error in the rate riders that were included in the Tariff of Rates and Charges for the Sentinel Lighting class in the DRO Decision, as defined below.

In Decision and Order EB-2022-0043,<sup>1</sup> the OEB approved the disposition of two rater riders for the Sentinel rate class over a two-year period as part of its 2023 IRM application ("**IRM Decision**"). The OEB issued its Decision and Order on InnPower's 2024 Cost of Service application on November 23, 2023 approving the filed Settlement Proposal ("**Settlement Proposal**"). On December 14, 2023, the OEB issued a Final Rate Order approving InnPower's draft rate order and proposed Tariff of Rates and Charges ("**DRO Decision**").

Subsequent to these determinations by the OEB, InnPower identified a typographical error where the rate riders for the Sentinel rate class approved in the IRM Decision were not included in the Sentinel Lighting class Tariff of Rates and Charges for either the Settlement Proposal or DRO Decision. The amounts approved for the Sentinel Lighting class in the IRM Decision were not included in the following categories of the Tariff of Rates and Charges:<sup>2</sup>

• Rate Rider for Disposition of Global Adjustment Account (2023) - effective until December 31, 2024 Applicable only for Non-RPP Customers

• Rate Rider for Disposition of Deferral/Variance Accounts (2023) - effective until December 31, 2024

InnPower is requesting, pursuant to section 41.02 of the Rules of Practice and Procedure, for the OEB to correct this typographical error by:

- 1. replacing the Sentinel Lighting class Tariff of Rates and Charges included at page 7 of Schedule A to the DRO Decision with Schedule A, which now includes the rate riders approved in EB-2022-0043;
- 2. replacing Appendix D of the Settlement Proposal with the attached Schedule B to reflect the correct bill impacts for the Sentinel Lighting class;
- 3. replacing page 107 of the Settlement Proposal with Schedule A, which now includes the rate riders approved in EB-2022-0043; and
- 4. update the Tariff Schedule and Bill Impact Model with the excel files attached as Schedule C.

InnPower confirms that these corrections will only impact the Sentinel Lighting class.

To minimize the changes required to the Settlement Proposal or DRO Decision, InnPower is requesting that the OEB issue the amended order or decision with the same effective date of January 1, 2024. InnPower bills customers on February 15, 2024 for consumption in January 2024 and would appreciate if the OEB could make a determination on this issue prior to this date.
