Issues:

OPG has applied for changes to the calculation of amounts for the Hydroelectric Surplus Baseload Generation Variance Account and the Hydroelectric Incentive Mechanism, and for the treatment of real-time make whole payments due to expected changes to Ontario's electricity market under the IESO's Market Renewal Program. OPG is also asking for approval to dispose of certain deferral and variance accounts. AMPCO is intervening to review OPG's proposed changes and will represent the interests of Large customers.
