## 1. INTRODUCTION AND SUMMARY

This is the Final Rate Order on an application filed by Alectra Utilities Corporation. (Alectra Utilities) on July 21, 2023, seeking approval for an incremental capital module (ICM) rate rider for its PowerStream and Enersource Rate Zones (RZs), effective January 1, 2024. As the Decision and Order in this proceeding was only issued on February 13, 2024, the OEB directed that changes to rates are to be effective and implemented from March 1, 2024.

The OEB has reviewed Alectra Utilities' draft rate order (DRO), and the revised Tariff of Rates and Charges, the OEB is satisfied that they accurately reflect the Decision and Order from this proceeding.

As a result of this Final Rate Order, for the PowerStream RZ, there will be a monthly total bill increase for a residential customer consuming 750 kWh as follows:

- March 1 to December 31, 2024
  - \$0.19 per month
- January 1, 2025, until Alectra Utilities' next rebasing application
  - \$0.16 per month

This change does not factor in applicable taxes or the Ontario Electricity Rebate.

The OEB did not approve ICM funding for the Enersource RZ.

## 2. PROCESS AND CONTEXT

In its Decision and Order, the OEB approved ICM funding of \$17.3 million for the PowerStream RZ and no funding for the Enersource RZ. The OEB further ordered Alectra Utilities to file a DRO and allowed for comments on the DRO by OEB staff and intervenors.<sup>1</sup>

On February 20, 2024, Alectra Utilities filed its DRO with a revised Tariff of Rates and Charges.<sup>2</sup> On February 27, 2024, OEB staff filed its submission on the DRO and submitted that Alectra Utilities had accurately updated the ICM models, and 2024 Tariff of Rates and Charges for the PowerStream RZ to reflect the OEB's findings in the Decision and Order. No intervenors filed comments on the DRO.

Alectra Utilities replied to the OEB staff's submission on February 28, 2024, noting that it had no further comments.<sup>3</sup>

### 3. FINDINGS

The OEB has reviewed the revised Tariff of Rates and Charges and finds that it accurately reflects the Decision and Order issued on February 13, 2024.

The OEB approves the Tariff of Rates and Charges in Schedule A, effective March 1, 2024.

## 4. ORDER

### THE ONTARIO ENERGY BOARD ORDERS THAT:

1. The Tariff of Rates and Charges set out in Schedule A of this Final Rate Order is effective March 1, 2024. The Tariff of Rates and Charges will apply to electricity consumed or estimated to have been consumed on and after March 1, 2024.
2. In this Decision and Final Rate Order Alectra Utilities Corporation shall notify customers in its PowerStream rate zone of the rate changes no later than the delivery of the first bill reflecting the new rates.

### RESIDENTIAL SERVICE CLASSIFICATION

This classification refers to an account taking electricity at 750 volts or less where the electricity is used exclusively in a separately metered living accommodation. Customers shall be residing in single-dwelling units that consist of a detached house or one unit of a semi-detached, duplex, triplex or quadruplex house, with a residential zoning. Separately metered dwellings within a town house complex or apartment building also qualify as residential customers. Multi-unit residential establishments such as apartment buildings supplied through one service (bulk metered) shall be classified as general service. Class B consumers are defined in accordance with O. Reg. 429/04. Further servicing details are available in the distributor's Conditions of Service.
